

## How can I make my arrival/dismissal more effective?

High traffic circulation and poor arrival/dismissal procedures can lead to unsafe conditions for student pedestrians and cyclists arriving to and from school. It is therefore important for school administrators to establish, monitor and enforce arrival/dismissal policies and procedures for a safer and more effective process at your school.

The following tips consider the use of school resources such as the supervision of areas, enforcement of procedures, specified routes for student pedestrians and cyclists separate from drop-off and pick-up areas, as well as student/teacher valets, and safety patrollers.



## **Arrival / Dismissal Policies:**

Establish dismissal policies and procedures collectively with school administrators, parent/ teacher organizations, the local community, and school board.

Establish a set and agreed upon dismissal method that everyone can honor and follow in your school.

Improves traffic operations and creates a safer arrival/dismissal on school grounds for students whether they are on foot, on bike, in a family vehicle or riding a school bus.

All parents should be notified of new policies via mail, email, phone, and meetings at the beginning of the school year. These policies should be available on the school website or community bulletin board to ensure access to changes in dismissal policy.

Consistently monitor and enforce policies for arrival/dismissal.	Keep everyone informed and following the assigned policies for a safer arrival/dismissal period.	Ensures that arrival/dismissal is consistent and provides safety for all mixed modes of travel.	Monitoring can be performed by school personnel, school police, parent/other volunteers, etc.

## Note that any or all of the recommendations or suggested policies above should be consistently monitored for effectiveness, revised as necessary, and reinforced to maintain a positive impact upon the school community.

The tips above have been verified against Miami-Dade County's Public Schools' *Parent + Student Handbook* to ensure that the recommendations above meet existing school protocols. Usage in other counties may differ.
